# OVERVIEW OF BRADENTON, FLORIDA

According to the 2023 County Health Rankings, the three major health outcomes that Florida performed poorly in were premature death in Years of Life Lost (7,500 FL vs 7,300 US), low birthweight (9% FL vs 8% US), and poor or fair health (13% FL vs 12% US).

# **KEY FINDINGS AND RECOMMENDATIONS**

Staff reported the need for building community awareness of Centerstone and its services. There is a desire for specific adult trainings for diagnoses such as Dementia and Alzheimer. Based on these findings we recommend working with the marketing team to increase awareness of services in the community and continue to develop more adult trainings, increase staff, and create pipelines from local colleges to our clinics to increase hiring pool candidates.

Regarding community needs and areas of concern, 88% of external organizations believe alcohol is the most problematic substance in the community. Most also viewed getting quick access to mental health and substance use services as vital to addressing health problems. Recommendations for Centerstone are to reduce wait times for services, increase access to therapists, and conducting community awareness campaigns in the community.

Clients reported that the top three barriers to accessing healthcare were Financial/insurance concerns (53%), scheduling/availability (38%) and necessary services not being available (25%). The top three healthcare services most difficult to get quality services reported by clients were general/family healthcare (34%), childbirth/women services (28%) and rehabilitation (28%). Recommendations based on these findings are to increase available CCBHC services for those who are financially limited and increasing technology within the clinic to improve scheduling and availability of clinicians.

# **MENTAL HEALTH**



POOR MENTAL HEALTH DAYS

Average number of poor mental health days in the past 30 days the Bradenton Catchment Area.

FL averages 4.2 days of poor mental health.



FREQUENT MENTAL DISTRESS


The FL rate (13%) is slightly less than the US rate of 14%.

SUBSTANCE USE

### **SUICIDES PER 100K**

The majority of counties in Bradenton's catchment area have higher rates of **suicide** then on average for the US.



### SUBSTANCE USE DISORDERS

As shown below, the average Illicit Drug Use Disorder within the Bradenton Catchment Area (2.5%) is similar to the US average (3%). Additionally, Alcohol Use Disorder was slightly lower than US average at 6%.

SUBSTANCE USE DIAGNOSIS
As shown below, average overall substance use diagnoses within the Bradenton
Catchment Area (8%) was slightly higher than the average in Florida at 7%.

### POOR PHYSICAL HEALTH DAYS


Average number of poor physical health days in the past 30 days in the Catchment Area. FL averages 3.0 days of poor physical health.



The Bradenton Catchment Area has on average lower access to exercise opportunities than FL and the similar access to exercise opportunities as the US at 84%.

### PHYSICAL INACTIVITY

DeSoto county (38%) has substantially higher rates of adult physical inactivity vs 22% US and 26% FL.





### SOCIAL DETERMINANTS OF HEALTH

This section explores the social and economic factors, such as income, education, housing, and access to resources, that shape health outcomes and contribute to disparities.

# **ACCESS TO HEALTH SERVICES**



### **Financial Concerns Limit Access**

Of the 45 staff participants interviewed, 87% stated financial / insurance concerns were a key barrier to accessing healthcare.



### A Lack of Transportation

**56%** of staff stated that **transportation to services** was a key barrier for clients seeking care.



### **Mental & Physical Health Services**

When assessing the top 3 most difficult services to access, 49% of staff listed mental & physical services in their top 3.

# **EDUCATIONAL ATTAINMENT**



Hillsborough County has the lowest educational attainment of the counties assessed.

Only 12% of Hillsborough County Residents have at least a Bachelor's Degree. This rate is more than two times lower than the state proportion (30.5%).



Sarasota County has the **strongest** academic performance of all the counties.

93% of residents have at least a high school diploma, compared to the state average of 88.5%.

# SOCIO-ECONOMIC STATUS

Economic factors such as education and income correlate with better access to care, which requires not only financial coverage, but access to providers as well. Sarasota County stands out with a Gini index of income inequality score higher than the state (0.51 vs. 0.49), suggesting a greater level of income disparity within the community.

DeSoto and Hillsborough Counties have the most socio-economic disadvantages in the Catchment areas as shown by the Area Deprivation Index.



# **HOUSING & FOOD INSECURITY**

Hillsborough County has the highest rates of severe housing problems.

DeSoto County has the highest food insecurity rates.







### SERVICE NEEDS

This section assesses the adequacy, accessibility, and availability of healthcare services to address identified health priorities and reduce barriers linked to social determinants.



### **Difficulty Accessing Mental Health Services**

82% of organizations scored mental health services as the most difficult for the community to access.



### The Significance of Substance Abuse Services

Of the external organizations surveyed, 76% of the participants scored substance abuse services as important for the community to have access to.



### **Accessibility of Substance Abuse Services**

**59%** of organization participants scored substance abuse services as the most difficult to access.

# **FUTURE DIRECTIONS**





### **WORKFORCE**

In years 3 and 4 of the grant, consider hiring 2 Licensed Therapists and 2 Care Coordinators. Additionally, hire 1 bilingual staff/therapist (Spanish & English).



### **CLIENT ENGAGEMENT**

In years 3 and 4 increase awareness in community of Centerstone's services. Conduct an awareness campaign in Spanish speaking communities and create a community advisory board with community members as participants.



### **COLLABORATING PARTNERS**

In years 3 and 4 add 2 more designated collaborating partners. Consider collaborating with a local university.

Information from internal and external sources (e.g. Enlighten Analytics, SAMHSA, CDC), including feedback from Centerstone staff, clients, and community organizations (Nov 2023–Mar 2024), is shared to enhance care access, health outcomes, and tailored service delivery.
